


The Synchrotron and Neutron Users' Group (SNUG) represents:

SNUG strategy: visit Washington-show user facility importance for international competitiveness; support-

- Rising above gathering storm: National Academy Report proposes.
 - Train science and math teachers
 - Support science and math students
 - Double physical science budget
 - Tax credits for industrial research
 - Broad support in Congress
- National Competitiveness Initiative
 - Double Physical Science (DOE) budget in 10 years
 - Broad support in Congress-but emphasis depends on party


APSUO recognized need for individual visits to congressional representatives in home states

Dear Dr. Kopp:


